PARISH BURIAL GROUND FEES (Effective from 1st April 2018):

Charge Application and Variations

Standard charges apply to:

- A person who, immediately before death or when reserving a plot, was resident in Christian Malford Parish;
- A person who has been resident in Christian Malford Parish for not less than fifty years;
- Burial in a previously purchased reserved plot or second burial in an existing plot;
- Children of parents currently resident in Christian Malford Parish;
- A person who, prior to death, was resident in hospital, home for the elderly, chronically ill or similar and, who immediately before removal to such place, was resident in Christian Malford Parish.

Double charges apply to a person who does not fall within the Standard Charge categories but who in the past was resident, or whose parents or grandparents were at some time resident in Christian Malford Parish.

Notes on Interments:

- A *Plots may be reserved prior to death on payment to the Parish Council of the Plot Fee (Exclusive Rights to apply for 100 years from the date of grant).*
- B *Burials in Reserved Plots & second burials in the same plot require payment of the Burial Fee only.*

Memorials - Headstones, Monuments, Tablets & Inscriptions	Fee
Erection of Headstone and Base - not exceeding 30" high x 18" wide	£115
Small Cremation Plaque - flat stone not more than 12" x 18"	£ 55
Additional Inscription after the first or other works to the memorial	£ 55
Replacement of memorial	£ 55

Notes on Memorials

- 1 *Cremation plaque fee includes first inscription (if the plaque includes a raised section of any description the full fee for a headstone is payable).*
- 2 *Designs and inscriptions must be submitted to the Clerk for the Council's approval.*
- 3 *Contractor's trade names shall not be inscribed on memorials.*
- 4 *Trees and shrubs may not be planted without special permission.*
- 5 *In the interests of burial ground maintenance, no form of permanent memorial is permitted other than the headstone and plaques specified above. Any form of cultivation, planting or additional stonework may be removed at any time without notice.*
