085⁽²²⁾ Declarations of interests from members regarding matters on the agenda

086⁽²²⁾ Public Forum Session

A query was raised about why the Parish Notice Board at the shop was no longer being used to post Agendas, etc - the Clerk advised it was stopped during the pandemic and Cllr K Assinder agreed to post Agendas, etc going forward.

090⁽²²⁾ Neighbourhood Development Plan (NDP) Review

Cllr Depla invited the Chair of the NDP Review Team to give an update. NW reported that he had a frustrating meeting with Wiltshire Council who advised that there was no need to carry out a review but if we did it would essentially need to be a full review, including public consultations, re-writing of

091⁽²²⁾ Highways, Parish Steward and Community Speed Watch

Cllr I Patterson reported on the latest stats from the SID and advised that Lyneham Banks was likely to remain closed until the end of 2023. The Clerk had not received a reply from Wiltshire Highways on the request for a temporary 20mph speed limit along Station Road whilst the B4069 closure remained in place – she will chase-up her email to see what can be done. The Parish Steward carried out a variety of tasks in July and the Clerk was asked to send a letter to residents either side of the entrance to the Rec to ask that they cut back their overgrown hedges.

092⁽²²⁾ Recreation Ground

Cllr K Assinder reported that the Abba event went well and had no further matters to report.

093⁽²²⁾ Malford Meadow/Allotments

Cllr Hines's report was noted in his absence. It was <u>agreed</u>, subject to conditions, to allow the bonfire event to take place on the Meadow in 2022. The Clerk agreed to liaise with PH on the proposed Gigaclear installation at the Pavilion.

094⁽²²⁾ Burial Ground

Cllr M Johnson's report was noted in her absence and the date for the tree works at the BG and Rec was noted as 16 August 2022.

095⁽²²⁾ Rights of Way & Village Assets

Cllr I Kirkpatrick reported on several matters and advised he was waiting for quotes from the Maintenance Officer for urgent repairs to a stile and footbridge on CMAL1.

096⁽²²⁾ Village Hall

No update report was received.

097⁽²²⁾ Flooding/Emergency Plan

Cllr M Cox reported on his recent inspection of Pug Brook and advised he will organise a date for a working party to help clear it further. He agreed to draft a letter for the Clerk to send to the landowner at Lye Common to request access/help in clearing the brook that runs across their land.

098⁽²²⁾ Environmental/Sustainability Matters

No update report was received.

099⁽²²⁾ Wiltshire Council

Cllr H Greenman reported that Ollie Phipps, Community Engagement Manager for Chippenham Area Board, had resigned and that his replacement would have to deal with a larger area – to include Calne and Corsham. He gave details on the incinerator application in Westbury that had been refused and was likely to go to Appeal, and on the applications for more solar farms in Wiltshire.
