176⁽²²⁾ Apologies and Reasons for Absence

No apologies were received.

177⁽²²⁾ Declarations of interests from members regarding matters on the agenda

No declarations of interests were received.

178⁽²²⁾ Public Forum Session

No matters raised.

179⁽²²⁾ Minutes for Approval

It was <u>resolved to approve</u> the minutes of the Parish Council Meeting on 6 December 2022 and they were duly signed.

180⁽²²⁾ Village Hall – Planning Application

Cllr S Depla invited the Paul McPherson, Chair of the VHMC, to present details of the planning application for the new Village Hall that they were seeking support for from the Parish Council. It was <u>resolved to support</u> the application and the Clerk agreed to send the appropriate letter

181⁽²²⁾ Finance

- a) It was <u>resolved to approve</u> the monthly accounts statement and new invoices totalling £770.75 for online payment.
- b) It was <u>resolved to approve</u> the 2023-2024 Budget (v2.0) and Precept at £27,838.75, which represents a 2.95% increase on 2022-2023.

182⁽²²⁾ Planning

It was <u>noted</u> that all Councillors <u>agreed</u> to a No Comment response on PL/2022/09653 – Barn House and on the Pre Planning Consultation Cornerstone 127200 for a telecoms tower.

183⁽²²⁾ Neighbourhood Development Plan (NDP) Review

Cllr B Kimber reported that they were still waiting for confirmation from Wiltshire Council on the housing figures.

184⁽²²⁾ Highways, Parish Steward, CSW and Speed Indicator Device

Cllr I Patterson gave an update on the yearly stats from the SID and there was a discussion on how to try and encourage more CSW volunteers. Cllr Hines said he would chase-up our request for speed checks from the police. IP further reported on matters to be dealt with by the Parish Steward and it was noted that there was still no further update from Wiltshire Council on the dropped kerbs at Roundwood View – the Clerk said the LHFIG team were meeting on 24-Jan-2023 and she was hoping for an update soon.

185⁽²²⁾ Recreation Ground

Cllr K Assinder had nothing to report.

186⁽²²⁾ Malford Meadow/Allotments

Cllr Hines reported that they were hoping to plant the 30 trees soon but he was still waiting for a quote from the Maintenance Office to install the tree stakes.

187⁽²²⁾ Burial Ground

Cllr M Johnson reported that she had made no progress with A Crotty regarding the contract for the fencing and bench at the Memorial Garden and it was agreed that the Clerk would find another contractor.

188⁽²²⁾ Rights of Way & Village Assets

Cllr I Kirkpatrick had nothing to report. Cllr Assinder was still waiting to hear from the Maintenance Officer on the installation of the goal posts but said he was hoping to have them in by the end of February.

189⁽²²⁾ Village Hall

There was nothing further to report.

190⁽²²⁾ Flooding/Emergency Plan

Cllr M Cox reported that, despite the amount of snow and rain we had had recently, he was really amazed at the lack of flooding – which he attributed to the clearance work that had been done at Pug Brook. He raised some concerns over the stability of a gabion wall that had been installed at one of the gardens in Lye Common with regard to it potentially collapsing into Pug Brook.

Cllr B Kimber asked if she could purchase an extra long litter picking tool to help with the removal of rubbish from deep ditches – this was **agreed**.

Cllr H Greenman reported on the proposed planning developments to the South and East of Chippenham and the potential traffic issues they might cause, especially the one to the South.
