#### 050<sup>(23)</sup> Recreation Ground

Cllr K Assinder reported that the moss needs to be cleared from the MUGA and would get a price for some industrial strength moss killer. He'd also had a meeting with a couple of residents on the refurb project for the Junior Play Area to help move it forward.

# 051<sup>(23)</sup> Malford Meadow/Allotments

Cllr Hines reported that some of the grass had been cut by local residents, there was a planned delivery of compost for the Allotmenteers and sunflowers had been planted on the bonfire patch. It was agreed that the guards around the saplings needed expanding and weeds need clearing to help them thrive.
