079⁽²³⁾ Apologies and Reasons for Absence

Apologies were received from Cllrs B Kimber (work), P Hines (work), I Patterson (holiday) and from the Clerk (Covid).

080⁽²³⁾ Declarations of interests from members regarding matters on the agenda

No declarations of interests were received.

081⁽²³⁾ Public Forum Session

2 residents on Main Road raised the issue of two small trees that have grown in the ditch causing visibility problems when leaving their driveway – and wanted to know who were responsible for maintaining them. They were advised that it was probably Wiltshire Highways and advised to report it via the MyWilts App.

082⁽²³⁾ Minutes for Approval

It was <u>resolved to approve</u> the minutes of the Parish Council Meeting on 12 July 2023 and they were duly signed.

A brief discussion took place on the application in Sutton Benger for 60 houses (PL/2023/06204) on the east side of the village that will impact on the gap between our 2 villages. Cllr H Greenman gave an update on the Regulation 19 consultation on the draft Local Plan which recommends a nil residual requirement for housing for both Sutton Benger and Christian Malford till 2036 and he urged everyone to submit their comments on this application – the date to respond by having been extended to 14 September 2023.

c) Notification of Planning Appeal for PL/2021/11163 – Christian Farm – It was <u>resolved</u> that no further comments needed to be submit to the Planning Inspectorate in respect of this Appeal.

085⁽²³⁾ Neighbourhood Development Plan (NDP) Review

Cllr B Kimber's update was noted in her absence. Cllrs gave their appreciation of the work carried out so far, particularly re the village questionnaire. To keep momentum going, it was requested that the results were compiled and circulated to the PC by 27 Oct to be presented at the following Nov PC Meeting on 1-Nov-2023.

086⁽²³⁾ Highways, Parish Steward, CSW and Speed Indicator Device

Cllr I Patterson's updates were noted in his absence. Discussion was had re the extraordinary speeds that some are hitting in/near the village. The next Rural Parishes Forum on 18 October will have the police presenting, one/some of the PC members will be attending to raise our concerns along with the data.

087⁽²³⁾ Recreation Ground

Cllr K Assinder's report was received, and it was noted that they would be having a meeting in a few weeks with a consultant to have a professional proposal for the play area refurb project.

088⁽²³⁾ Malford Meadow/Allotments

Cllr Hines's update was noted in his absence, and it was noted that the grounds maintenance works by Idverde had still not been carried out according to the contract. It was <u>resolved to approve</u> the expenditure of £200 for new stakes and guards to protect the trees we planted. It was also <u>agreed</u> that Cllr Hines would arrange for the hedge and bramble maintenance to be carried out.

089⁽²³⁾ Burial Ground

Cllr M Johnson's was received, and it was noted that Idverde had not carried out the grounds maintenance works as promised and the wildflower area had still not been cut. It was agreed to ask the Clerk to put together a new tender for the grounds maintenance contracts for 2024.
